- New information that enhances knowledge on the disease process, including the discovery of new ancillary techniques for diagnosis.
- 3. Unusual, clinicopathological features that need further study.

ASOMP-CPC Case Submission Requirements:

- 1. General Requirements. All cases should be submitted via email to secretary@asomp.com
- Author Information. Name & title, institutional affiliation, email address, phone number & HOD consent if the case is submitted by a student.
- 3. Social handles for authors and their institutions, if available.
- 4. Author Photo. Please submit a "head shot" to be posted with your case.
- Clinical history. Brief introductory paragraph about the patient or biopsy. Include essential clinical information (HPI, relevant medical history, physical exam findings, lab tests & prior treatments)

- Images: high resolution images of clinical radiographic, pathologic
 & special techniques findings whenever indicated. In general, multiple radiographic views/MRI/CT images. All images should be submitted at 300dpi
- 7. Video: Videos should be high resolution, narrated, and 30-90 seconds in length
- 8. Format. Files may be no larger than 50 MB
- If the case is posted the author will be required to respond to readers' comments online for the first month that the case is online.

Sample ASOMP-CPC Case Outline

- Brief synopsis about the patient or biopsy (essential clinical information - HPI, relevant medical history, physical exam findings, lab tests & prior treatments)
- 2. Imaging Provide high resolution images with descriptions of the relevant radiographic findings
- 3. What's your differential diagnosis?:
- 4. What's your next step?: Which of the following is most likely to confirm the diagnosis? (could include immunohistochemical or special stains, genetic testing, in situ hybridization or other ancillary techniques)
- 5. Synopsis of Results: Provide a synopsis of the results and diagnosis based on the testing discussed.
